The March 2016 election included the Presidential Preference Primary, party committees, a municipal election for Greenwood Mayor, a special election for Court of Appeal judge (2nd Circuit, 3rd District, Election Section 1-A), and a proposition election for Fire District 8. The Presidential Preference Primary election for nominees for U.S. President was a closed-party primary where **only** registered Democrats could vote for Democratic candidates and **only** registered Republicans could vote for Republican candidates. The party elections for the Democratic and Republican State Central Committee members as well as Democratic and Republican Parish Executive Committee members were also closed-party, where **only** registered Democrats could vote for Democratic candidates and **only** registered Republicans could vote for Republican candidates. These party elections included contested Democratic State Central Committees, Districts 2-B, 5-A, 5-B, and 6-B; contested Republican State Central Committee members, Districts 37-C and 38-D; contested Democratic Parish Executive Committee members, Districts 3, 4, 5, 9, and Member at Large; and contested Republican Parish Executive Committee member, District 8. The local elections for Court of Appeal judge, Greenwood Mayor, and Fire District 8 were open primary elections, so all voters registered within the districts were eligible to vote on those elections, regardless of their party affiliation.

The April 2016 election included one proposition for the Caddo-Bossier Parishes Port Commission, three propositions from the Caddo Parish School District, and one proposition for Fire District #4. The polling place for Precincts 047 and 083 was changed from Ford Park Baptist Church to Western Hills Baptist Church with an emergency relocation due to damage following flooding in March.

The November 2016 election included Presidential Electors, U.S. Senator, U.S. Representative, a special election for Juvenile Court Judge (Election Section 1-C,) Ida Aldermen, Oil City Aldermen (Districts 4 and 5,) Rodessa Mayor, a special election for Blanchard Mayor, one proposition for Shreveport, three propositions for Vivian, five propositions for Blanchard, and six Constitutional Amendments.

The December 2016 election included run-off elections for U.S. Senator, U.S. Representative, and Juvenile Court Judge (Election Section 1-C,) as well as four Home Rule Charter Amendments and one proposition for the North Caddo Parish Hospital District.

Unless otherwise noted, charts show only the Caddo Parish portion of results.

Text of proposition as it appeared at the polls:

Parishwide Home Rule Charter Amendment Propositions
Proposition No. 1

Shall Paragraph I of Section 3-07 of Article III of the Caddo Parish Home Rule Charter be amended to read as follows? Voting shall be by electronic, roll call or voice roll call on ordinances or upon motion of two (2) or more commissioners, and the ayes and nays shall be recorded in the minutes of the commission by the individual vote of each commissioner. Not less than a majority of the membership of the commission shall constitute a quorum to transact business, but if a quorum is lost during a meeting, a smaller number may recess from time to time and compel the attendance of absent commissioners in the manner and subject to the penalties prescribed by commission rules.
