

April 29, 2017

The March 2017 election included one proposition for Fire District #1.

The April 2017 election included four propositions for the Caddo Parish Commission and one proposition for Sales Tax District #1 (areas in the parish outside the limits of Shreveport and Vivian.) The polling place for Precincts 142 and 156 was changed from Oil City Community Center at 310 Savage Street in Oil City to Oil City Community Center at 103 Highway 1 in Oil City with an emergency relocation due to damage from a leaking water pipe.

The October 2017 election included a special election for State Treasurer (following the vacancy created by John Kennedy's election to U.S. Senate in December 2016); a special election for Parish Commission member, District 12 (following the resignation of Ken Epperson in December 2016); two propositions for Fire District #5; and three Constitutional Amendments. The polling place for Precincts 142 and 156 was changed from Oil City Community Center at 103 Highway 1 in Oil City to Oil City Community Center at 310 Savage Street in Oil City. Other polling place changes included Precincts 105 and 162 from Caddo Fire District #4 to Providence Road Baptist Church; Precinct 109 from Grace Community United Methodist Church to Ellerbe Road Baptist Church; and Precincts 110 and 128 from Grace Community United Methodist Church to Norris Ferry Community Church.

The November 2017 election included run-off elections for State Treasurer and for Parish Commission member, District 12, and one proposition for Sewerage District No. 2.

Unless otherwise noted, charts show only the Caddo Parish portion of results.

(Sales Tax Rededication)

Shall Caddo Parish, Louisiana (the "Parish"), be authorized to rededicate all of the proceeds hereto or hereafter received by the Parish from the levy and collection of the following sales taxes (collectively, the "Sales Taxes") levied within Sales Tax District Number One of Caddo Parish (the "District"), namely (i) the 1% sales and use tax authorized at elections held on November 8, 1988 and May 5, 2007 and (ii) the 1/2% sales and use tax authorized at an election held on March 10, 1992 (an estimated \$8,775,000 reasonably expected at this time to be collected from the levy of the Sales Taxes for an entire year), so that such proceeds may be used for the purpose of acquiring, constructing, improving, operating and/or maintaining public streets, roads, highways, bridges, drainage systems, solid waste collections and disposal, waterworks and sewers and sewerage disposal works within the District and shall the Parish be further authorized to fund the proceeds of the Tax into bonds from time to time for any of said capital improvement purposes in the District, to the extent and in the manner permitted by the laws of Louisiana?
