The April 2013 election consisted of five propositions for the City of Shreveport for only those voters registered within Shreveport.

The May 2013 election included three parishwide School Board propositions.

The October 2013 election featured the special elections for the following:

District Court Judge – due to the resignation of Judge Jeanette G. Garrett

Parish Commission Member – due to the death of Joyce Bowman

Blanchard Alderman – due to the resignation of Ross V. Prewett, III

Additionally, the October 2013 included one parishwide proposition for Parish Commission and one Home Rule Charter amendment for the Parish Commission.

There was no other election during the fall of 2013.
